COMES NOW jeffrey-allen: hill, in esse and sui juris, over the age of majority, cognizant of the importance of the matters stated herein and competent to give testimony, solemnly makes oath that this document supersides all filings Declarations and Registrations of Status of , by and for "Jeffrey Allen Hill", the following statements being true and correct to the best of his knowledge and experience:

I, jeffrey-allen: hill, now known as: MattithYah-YirmeYah: Achukma, c/o p.o. box 3784, macon, georgia [31205], herby with plainess and clarity solemnly and under invocation of All My Unalienable Rights and acceptance of the Guarenteed protections of, in accordance with: the 1931 Statute of Westminster¹, 1778 Articles of Confederation and Perpetual Union-Art XI, 1812 Treaty of Ghent, 1794 Jay Treaty; 1836 Treaty of Marrakesh (Morocco) all recognized and valid treaties, constitution for the united states of America, the 1948 Charter of the United Nations, Pope's Apology to Indigenous Peoples², United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP)³, the American Declaration on the Rights of Indigenous Peoples⁴, the UN International Decade for People of African Descent⁵ and the Achukma Nakni Chihowa Nation Trust, Declare following:

PART I: Declaration of Decendancy and Nationality

- 1. I jeffrey-allen: hill am an [Indigenous] Autochthonous American [Aborigine/Aboriginal], Living Flesh & Blood being, National of the Empire Washitaw de Dugdahmoundyah Mu'urs⁶, Member of the and Chief of the Achukma Nakni Chihowa Nation, having decendency of the Xi,(Olmec, Washita, Yamasee,Arawak, Creek and Chikasa/Chahta) Hebrew/Israelite peoples, Whose origins are in the original peoples of North and South America (including Central America), and in the origins in the original peoples of Europe, the Middle East, or North Africa.
- 2. I jeffrey-allen: hill am a bloodline member of the Achukma Nakni Chihowa Nation
- 3. I, jeffrey-allen: hill, willingly and knowingly invoke and exercise my right to a nationality.
