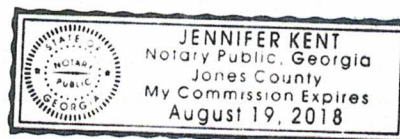

Notice and Revocation of Power of Attorney and Revocation of Signatures

In Propria Persona By Special Appearance:

COMES NOW Jeffrey Allen Hill, Sui Juris, the Movant in the above entitled action, to Provide Notice to all interested parties of His lawful Revocation of Power of Attorney, to wit:

Know ALL MEN AND WOMEN BY THESE PRESENTS, that I, Hill, Jeffrey-Allen:, (proper name Jeffrey-Allen: Hill) Sui Juris, BEING FIRST DULY SWORN, deposes and says that:

I, Hill, Jeffrey-Allen:, Sui Juris, as a lawful Aborigine American of Hebrew Nationality of the ACHUKMA NAKNI CHIHOWA Tribe, and I Do hereby wholly REVOKE, CANCEL, and ANNUL all Powers of Attorney, expressed, Implied in fact or otherwise, signed or otherwise consented to by Me, My agent(s) ,Parents, parsens patriae, implied in law or by trust, voluntary or involuntary, with or with Out My informed consent and knowledge, as these revoked Powers of Attorney Pertain to Me, and to the property both real and personal, obtained by Me in the past, ANY other evidence or presumption to the contrary is hereby REBUTTED.

I hereby am rescinding and revoking ANY and ALL PAST initial signatures, marks, seals and/or authorizations, including but not limited To Pleas, drivers licenses, vehicle, registrations, birth or trust certificates, voter Registrations, and all other franchises with any agency of the government, were signed or otherwise entered in ERROR, and were involuntarily made under threat, duress and coercion (hereinafter "TDC") . All signatures that were not properly signed By: __ as agent and/or authorized rep.

I hereby REVOKE, cancel and render NULL and VOID, Nunc Pro Tunc, both Currently and retroactively to the date and time of My signing or other apparent consent, Any and all such contracts including Pleas entered in any court of this state or any other state in which were unconstitutional laws forced upon me without my consent.

Any and all criminal or civil cases, in which I was coerced, threaten and force into without my consent. Any and all bail bonds in which I was extorted, forced into and not given full complete disclosure and there was no meeting of the minds.

NO man, woman, elected official, public servants, bureaucrat, corporation, Government, state. Or other artificial "person" has ANY authority whatsoever to act on my behalf, nor to represent Me in a court of law, nor for ANY legislature or judicial Tribunal, or ANY agency of the state, local government, to make non-positive law that Binds Me to ANY unconscionable adhesion contract that i have not entered into knowingly, intentionally, and voluntarily.

In the Nature and intent of the 1877 Georgia Constitution (as ratified without subsequent amendments) and BILL OF RIGHTS

ARTICLE I. BILL OF RIGHTS. SECTION I.

Par. XVIII. The social status of the citizen shall never be the subject of legislation.

SECTION IV.

Paragraph I. Laws of a general nature shall have uniform operation throughout the State, and no special law shall be enacted in any case for which provision has been made by an existing general law. No general law affecting private rights, shall be varied in any particular case, by special legislation, except with the free consent, in writing of all persons to be affected thereby; and no person under legal disability to contract, is capable of such consent.

Par. II. Legislative acts in violation of this Constitution, or the Constitution of the United States, are void, and the Judiciary shall so declare them.

As I have not consent to writing to any of the laws of this State or any other state I cannot be bound by said, as said State(s) cannot legislate the social status of the citizen and said State cannot make the presumptions that I am a resident or domiciled in the said STATE OF GEORGIA, and all said presumptions are rebutted that I am resident of said state or that I intended to be a resident or a citizen of the State or of any COUNTY. I have chosen to Self-Governance under the ACHUKMA NAKNI CHIHOWA Tribe.

I retain and reserve all my natural rights given by my Creator CHIHOWA (Yahuwah) I owe all allegiance to him and him alone and thus cannot be a resident of the STATE OF GEORGIA or a citizen of THE UNITED STATES as it is our religious belief that we shall have no other mighty one before CHIHOWA (Yahuwah).

I have made, constituted and RESTORED my full power of attorney, EFFECTIVE IMMEDIATELY, Over all my individual and business affairs.

I have given and granted Myself full power and authority to do and perform all and Every act and thing whatsoever necessary to be done to ensure that the unalienable and Sovereign Rights secured by Me under the organic laws of the United States of America, The Declaration of independence (1776), the Constitution for the United States of America (1789), and the Bill of Rights (1791), two hundred years of American case law (I.e. common law), and the 1877 Georgia Constitution (as ratified without subsequent amendments) and BILL OF RIGHTS, of the sovereign state of the Georgia Republic, will be honored, respected, and promoted and defended.

And Further deponent saith not:

I now affix My signature and official seal to all of the above affirmations WITH EXPLICIT RESERVATION OF ALL OF MY UNALIENABLE RIGHTS, WITHOUT PREJUDICE TO ANY OF THOSE RIGHTS, PURSUANT TO UCC 1-102 ,1-103,6.

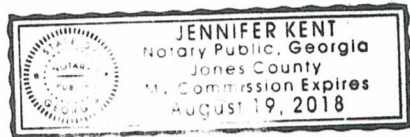
