## For Jeffrey-Allen: Hill-Yisra'el

### International Law Nationality Declaration in Affidavit form For an American Ab Origine Nationality

I, Jeffrey-Allen: Hill-Yisra'el am of the age of maturity to make this Declaration in affidavit form and the facts herein.

I, Jeffrey-Allen: Hill-Yisra'el am mentally competent to make this Official Declaration in affidavit form with Facts for the Record.

I, Jeffrey-Allen: Hill-Yisra'el have personal knowledge pertaining to the facts in this Declaration in affidavit form.

This testimony in the form of an affidavit is made under penalty of perjury and must be responded to by a counter affidavit by any and all parties within 30 days or it will stand as undisputed fact as a matter of law.

I, Jeffrey-Allen: Hill-Yisra'el declare under penalty of perjury that the foregoing is true and correct without the United States. [Made In accordance with Universal Declaration of Human Rights, UN res. 61/295 - Declaration of Human Rights, UN res. 60/147 Human Rights Law, Hague Convention, & Title 28 United States Code Annotated Section 1746]

In accordance with The Universal Declaration of Human Rights Article 15 to which the United States and all its departments are Subject,

2) No one shall be arbitrarily deprived of his nationality nor denied the right to change his nationality.

- \* In accordance with The Declaration of Indigenous Rights enacted by the Organization of American States which the United States and all its departments are subject to, All Articles Incorporated
- \* In accordance with the United Nations Declaration of the Rights of Indigenous Peoples UN 61/195, All Articles Incorporated
- \* In accordance with the UN 60/147 Basic Principles and Guidelines on the Right to a Remedy and Reparation for Victims of Gross Violations of International Human Rights Law and Serious Violations of International Humanitarian Law
- \* In accordance with the Great law of Peace as amended
- \* In accordance with United States Code Title 18 Section 112 Protections of Internationally Protected Persons
- \* In accordance with United States Code Title 18 Section 241 Conspiracy Against Rights & 242 Deprivation of Rights Under Color of Authority.

I, Jeffrey-Allen: Hill-Yisra'el, having the lawful and legal status as a National of an Aboriginal Autochthonous American and the status of Autochthonous American am an American National by contract and Treaty. I have a permanent allegiance to my ancestors by way of the Great law of Peace as amended.

My Lineage and Nationality is Autochthonous American Aboriginal from the Achukma clan(Tribe). I recognize and respect The Great law of Peace as amended. I recognize the laws governing the united states of America republic. I recognize all International Laws that apply to Autochthonous/Indigenous Peoples autonomy. I recognize the Constitution for the united states of America republic as the Supreme Law of the United States and its subjects along with all of the Treaties, which are also considered by some as the Supreme law of the land. I will honor all of the laws that pertain to my Autochthonous Nationality and status. By recognizing the laws of the United States of America I am not relinquishing any of my Autochthonous rights or liberties according to Treaty agreements.

I, Jeffrey-Allen: Hill-Yisra'el, am not a corporate citizen, fictitious entity, artificial person, 14<sup>th</sup> amendment citizen of the United States subject to the public debt obligation, or surety that is civilly dead. I am a Certified Ministerial Ambassador of my Autochthonous Government, Faith, and Spiritual Practices. I have no tax liability from any corporate agencies due to my status. I herein Reserve All of my inherent Natural Rights, Autochthonous Ab Origine Rights as an Autochthonous American, my Divine Rights, any and all Liberties, and all international rights and liberties that apply.
